By-Law Change Proposal

The board unanimously approved moving forward with this and Doug conducted the first reading at tonight's general membership meeting. The proposed change is as follows:

PROPOSED BY-LAW CHANGE — ARTICLE 5, SECTION 2, paragraph 2

Election of Officers shall be at the January December meeting, and a majority vote of the members present shall elect. All Executive Officers so elected shall hold office for one (1) year. The election of the Director positions will coincide with the election of Executive Officers. The term of office shall begin from date of election on January 1st and shall terminate with the election of new officers. Any member will be permitted to serve only two (2) terms as President consecutively.

Proposed deletions indicated by strikethrough, and proposed additions indicated in *italics*.

The second reading will be done at our March meeting to be followed by a vote of the members present.

Lake Pend Orielle Walleye Bounty Program

Shirley Calkins reported on this program being conducted by the Idaho Department of Fish and Game wherein fifty Walleye have been implanted with a chip. Those fish will be worth \$1,000 each to anglers who turn them in. IDFW is trying to rid Lake Pend Orielle of Walleye. See IDFG.Idaho.Gov for further details.
