## **By-Law Change Proposal**

The board unanimously approved moving forward with this last month and Mark conducted the second reading at tonight's general membership meeting. The proposed change is as follows:

# PROPOSED BY-LAW CHANGE — ARTICLE 5, SECTION 2, paragraph 2

Election of Officers shall be at the January December meeting, and a majority vote of the members present shall elect. All Executive Officers so elected shall hold office for one (1) year. The election of the Director positions will coincide with the election of Executive Officers. The term of office shall begin from date of election on January 1<sup>st</sup> and shall terminate with the election of new officers. Any member will be permitted to serve only two (2) terms as President consecutively.

Proposed deletions indicated by strikethrough, and proposed additions indicated in *italics*.

This amendment was adopted by a unanimous vote of the members present tonight.
