Fishing Reports

Travis has been fishing the Snake River since early June (most recently last Saturday) and reports that the catching has been outstanding with several Walleye trophies (all released) and eaters boated. He had the best success using purple lures, in bright sun, at about 20' +/- along the weed beds. The wind has been brutal at times.

Ken Lofquist (not here tonight) and his partner each caught a limit of nice eaters on the Spokane Arm last week.

Greg Koch fished the area of Buoy 7 and above on the Spokane Arm last Saturday. He landed several Walleye, as well as some Trout and Bass. He had the best success casting crankbaits along the mudlines at 5-15'; 30-35' was not productive.

Mike Cook fished at Kettle Falls last night and reported that it was slow.

Sunshine Report

Linda Allen has completed her chemotherapy and continues to improve. She may have to have another surgery of a relatively minor nature.

Sharon Blume continues to improve and is up and around.

George Allen will be having open-heart surgery on August $13^{\rm th}$ and will likely miss our August meeting.

Guest Speakers

Tonight's guest speaker will be Mike Cook, who took second place in our 2019 Tournament.
