Walleyes Unlimited Northwest is pleased to present the 2011 Washington Walleye Circuit. In connection with the Tournament Directors, we expect that this year's walleye circuit will continue to provide the enjoyment and competition that the anglers have come to know over the past years.

## 2011 Policies and Procedures

**Angler ID Numbers:** Again this year, we will require each angler to use their individual Angler ID Numbers. We ask that you please include this number for each team member on any application you send in. The unique number will alleviate similar name confusion and aid in points totaling and Circuit Standing maintenance. Angler IDs have already been created for anyone who fished a Washington State Walleye Circuit Tournament in 2004 through 2010. **Fish Bags:** Due to the success last year, we will again use Tournament Fish Bags instead of baskets throughout the weigh-in process. This will minimize the amount of time the fish is out of water. Each tournament will have bags available for angler use although we recommend anglers purchase their own to avoid having to wait for tournament bags.

**Dead Fish Policy:** The Dead Fish policy will remain consistent for the 2011 season. For each competition day, a team will be penalized 1/2 lb for each of the first two dead fish. If a team returns with 3 dead fish, the team will be disqualified for the day.

**WeighMaster Responsibilities:** The Weigh-Master will have sole authority over determining dead vs. live fish and whether size restrictions have been adhered to.

**Remaining Issues:** With the exception of the policies noted above, each Tournament Director will retain full control of their individual tournament. All Drivers' Meetings are mandatory as other Rules will vary from tournament to tournament. Please contact the appropriate Tournament Director for additional rules clarification.

**Circuit Scoring System:** During the construction of the new Circuit Database, WUNW decided to adopt a new scoring system that will be fair to all anglers and encourage all anglers to fish multiple tournaments to compete for the Angler of the Year title.

The First Place Team will be awarded weight + 100pts.

The Second Place Team's weight will be divided by the winning team's weight, multiplied by 100 and added to the weight.

For Example:

Winning Team's weight = 35 lbs  
 $35 + 100 = 135$  Circuit Points

2nd Place Team weight = 32 lbs.  
 $(32 / 35) \times 100 = 91.42 + 32 =$   
123.42 Circuit Points
